Sale of Consta**ti**a Flexibles to One Rock Capital Partners isompleted

After obtaining the necessary authorizations, Wendel announced today it completed the sale of Constantia Flexibles ("The Company") to an affiliate of One Rock Capital Partners, LLC ("One Rock").

The transaction generated net proceeds¹ for Wendel of $\leq 1,094$ million for its shares. Wendel earned upon closing additional proceeds of ≤ 27 million from the sale of some Company's ancillary assets bringing total proceeds to Wendel to $\leq 1,121$ million, i.e. a valuation over 10% higher than the latest NAV on record before the announcement of the transaction (as at March 31, 2023).
